MAHARASHTRA RIGHT TO PUBLIC SERVICES ORDINANCE, 2015.

No. EST. 2015/1560/D-2.—In exercise of the powers conferred by section 3 of the Maharashtra Right to Public Services Ordinance, 2015 (Mah. Ord. V of 2015), the Law and Judiciary Department being the Administrative Department in respect of State Legal Service Authority, Public Trusts and Partnership Firms, hereby notifies the public services to be rendered to the eligible persons by the Offices of the State Legal Aid Authority, Charity Commissioner and Registrar of Partnership Firms, alongwith the stipulated time limit, for providing such public services, the Designated Officers, First Appellate Authorities and Second Appellate Authorities, specified in the Schedule appended herewith, for the purposes of the said Ordinance:—
